General Guidelines for Presenters

&1. General Provisions

- 1.1. The abstract submission for 11th Congress of Integrative Psychotherapy will be open on 10 February 2023. The submission deadline is on July 31 2023 (23h59 CET). Abstracts must be submitted online via mail eaipcongress@mentalacademy.ge
- 1.2. The total number of individual paper including other forms, workshop or second authorship, should not exceed three.
- 1.3. The official languages of the congress are English and Georgian.
- 1.4. The person submitting the proposal is the primary contact person for all communications who is responsible for relaying information to all co-authors.
- 1.5. All authors are responsible for the ethical and clinical accuracy of presented work.
- 1.6. All presenters are expected to register for the conference and pay registration fees.
- 1.7. The submission can be performed only once.
- 1.8. Proposals that do not confirm to the guidelines will not be discussed.

&2. Structure of the Congress

- 2.1. Authors are invited to submit abstracts, classified by the panels.
- 2.2. There is a limitation of three submissions per individual.

2.3. Panels will have one Moderator. Participants will interact in the specified order under the guidance of the moderator.

&3. Time schedule

3.1. Workshops: total duration 90 minutes.

3.2. **Paper Sessions**: 20 minutes presentation of research findings or a clinical topic. The paper presentation will be placed with others thematically or by topic.



&4. Evaluation procedure

4.1. All submitted proposals will be reviewed by the International Scientific Committee.

4.2. Authors will be notified of the acceptance of their proposals.

4.3. The first author should confirm their attendance. The abstract will be removed from the congress program if the first author does not confirm attendance by the due date.

4.5. In case the first author is unable to attend the congress, a co-author (who is registered for the congress) may take the presenting author's place.

4.6. Further instructions for authors whose abstracts are accepted will be posted on the website.

4.7. Results of the review will be sent to the selected authors within 40 days of submission.

4.8. If a revision is required, the revised abstract must be sent back within a week.

&5. Participation and registration rules for Co-Authors

- 5.1. A single registration permits only one person to attend the congress.
- 5.1. Only abstracts of the registered candidates will participate in the paper reviewing process.
- 5.2. If the co-authors would like to attend the congress their registration and payment are required to be made independently.
- 5.3. The certificate will be issued for the registered co-authors.

&6. Abstract

- 6.1. Abstracts should represent original work.
- 6.2. The Abstract should be written in English with accurate grammar and spelling of a quality suitable for publication.

6.3. Documents received after the given deadline, due to any reason will not be accepted unless the deadline is extended.

6.4. The abstract should be submitted in the format of MS Word (.doc or .docx) document.

6.5. The first author is the presenting author and responsible for the abstract.

6.6. Abstract should be revised carefully before submission. Secondary submissions will not participate in the reviewing process.

Title: Times New Roman, 12 points, Cantered text in bold;

Body: Times New Roman, 11 points; Line spacing: 1, one column of text

7.2. proposals are requested as a Word document.

9.1. Workshops

- 250-word abstract for mini-workshop
- Title for each individual presenter's contribution
- Description of the methodology
- Detailed instruction
- Minimum required number of participants
- Keywords: (up to 3 words)

9.2. Individual presenters

- Name, email address, institutional affiliation, and home country for the presenter.
- Brief professional biography (word count should not exceed 70 words)
- If the presenter is a student the proposal must include information about student status and the study institution.
- Title of paper
- 250-word abstract for the paper
- Keywords: (up to 3 words)
